	delinquent behavior, encourage sound social decision-making behavior and reduce illegal substance abuse.						
	This program receives partial funding from the Anti-Drug Sales Tax Funds to support its mission and goals.						
	Under the program, a Family Court Services Juvenile Probation Officer and a uniformed Deputy Sheriff will make evening and late night supervision and surveillance checks on high-risk juvenile probationers. In exchange,						
	the Family Court will reimburse the Sheriff's Office at the hourly off-duty pay rate of \$33.00 per hour, up to						
	\$70,000 for 2018. This reimbursement is paid through inter-department billing.
