REQUEST SUMMARY	Jackson County, Missouri would like to continue an Agreement with the City of Independence, Missouri to purchase vehicle fuel for Public Works vehicles at the City's Public Works Facility site at 1030 S. Crysler in Independence, Missouri at a cost of eleven center per gallon over the purchase price. This would enable Public Works vehicles to have a place to fuel up that would not otherwise be available. Pursuant to Section 1030.2 of the Jackson County Code, the Pubic Works Department and the Purchasing Department recommend the award of a Twelve Month Term and Supply Contract for the furnishing of Vehicle Fuel for the Public Works vehicles with the City of Independence, Missouri, as an Acquisition from Other Government. This Award is made on an "as needed" basis and does not obligate Jackson County, Missouri to pay any specific amount.
