REQUEST SUMMARY	Due to the multitude of inclement weather events at the beginning of this year that lasted much longer than normal, the Road and Bridge Division of Public Works used more fuel than anticipated. There is concern that without these requested funds available the Division will not have enough fuel to accommodate the necessary activities through the end of the year. Fortunately, during this year's Road Program we were able complete the program with less oil material than expected. The savings incurred in the Road Oil line item will be better utilized for fueling the fleet. For the reasons above, we are requesting a transfer of \$30,000.00 within the Special Road & Bridge fund.
