SUBJECT:

Resolutions 20123 & 20197 – Stadium Seat Update

RECAP: Approximately 30,000 stadium seats were removed from Arrowhead stadium in the Spring of 2019. Jackson County is responsible for the disposal of surplus originating from the sports complex.

- A transfer of \$42,725 was approved by Resolution 20123 for the removal and storage of the stadium seats. The actual total cost for this is \$66,515. A. Arnold, a term and supply vendor, provided this service.
- Request for Qualifications 24-19 was issued seeking a qualified vendor to repurpose, recycle and/or sell said seats. Resolution 20197 awarded to Schneider Industries of Troy, Indiana. This contract is under the following basic terms:
 - \$75,000 to be paid upfront, with the intention of this covering the costs related to moving and storage
 - o After \$95,000 in fixed costs are covered, Jackson County receives 50% of net proceeds.
 - o The **estimate** given in the proposal for financial return to Jackson County after all expenses and profit share was \$266,675.
 - O Schindler is responsible for selling the additional seats they are unable to utilize in a bulk sale to a third party. Jackson County will also see 50% of this sale.
