<p>SUBJECT</p>	<p>Action Requested <input checked="" type="checkbox"/> Resolution <input type="checkbox"/> Ordinance</p> <p>Project/Title: A Resolution approving the Contractual Agreement between Jackson County MO and Advanced Correctional Healthcare Inc. to provide temporary mental health services for the Inmate Population until a contract is awarded to a qualified vendor.</p> <p>We are requesting to transfer \$42,351.70, within the Corrections General Fund, from first quarter salary savings to cover the cost of emergency, Mental Health Services for the Jackson County Detention Center, inmate population, resulting from Truman Medical Center's immediate termination of services effective Friday, March 27, 2020.</p> <p>This interim coverage will be provided by Advanced Correctional Healthcare Inc. at a rate of \$21,175.85 per month. We anticipate needing this coverage through May 2020, at that time the Mental Health Services Contract will be awarded to a qualified vendor.</p>

<p>REQUEST SUMMARY</p>	<p>The Department of Corrections requires temporary mental health services due to TMC terminating their current services effective 3/27/2020. Advanced Correctional Healthcare, Inc. is the current medical provider for the inmate population, and they are willing to provide transitional services until a permanent contract can be awarded to a qualified agency. This will ensure continued psychiatric medication management, appropriate classification of mental health watch inmates, and suicide precaution protocols.
