## **Notable Results:**

- Requested by the Court and Client to enter my appearance into a highly contested and publicized termination of parental rights case in 2019. I accepted the case on a pro bono (I receive no fee and I pay all the expenses) agreement. After reviewing the case, I felt the father had been taken advantage of by the system and we began the fight to reunite the father with his family. At the time I was requested to enter my appearance into the case on a pro bono request, the father had lost all of his efforts (over a year and a half of proceedings) to be reunited with his family. The Court was set to have the last hearing to terminate the father's parental rights at the time I entered my appearance. It is our understanding that no parent had ever won a termination or parental rights hearing in Jackson County in the last decade. We requested a 2-day trial and aggressively litigated the matter. The trial judge rejected the states case and reunited the father with his family. The Judge subsequently nominated and awarded me at the annual conference with the advocate of the year award.
- 3 Million award for teenage detainee that suffered brain damage by officers at the Juvenile Detention Center.
- Represented the United Auto Workers Teamster's Fund to obtain a confidential settlement against large pharmaceutical companies (Co-Counsel David Hoffa)
- The highest wrongful death verdict in Orange County, California (\$10.25 million) against a rehabilitation facility.
- Saint Louis Jury awarded \$48.4 million to an energy company that sued Chicago Title Insurance Co. for negligence. The award was the largest plaintiff verdict ever in St. Louis County and was also the state's largest plaintiff verdict that year.
- The highest wrongful death verdict in St. Louis County, Missouri (\$9.5 million). It was the second largest verdict of 2007 in Missouri.
- Settlement for \$10.5 million in his Jackson County lawsuit against the confidential warehouse facility and two confidential aerial lift defendants for a painter who received an electrical shock while power washing a warehouse.
- A \$10 million dollar settlement with confidential defendant for brain injury to a child.
- A \$5.9 million-dollar confidential settlement with trucking company.
- A \$2.53 million-dollar confidential settlement with trucking company.
- A \$1 million dollar settlement for two Kansas University students injured in a car accident in Colorado, Missouri.
- Multiple settlements in excess of \$1 million dollars, but due to confidentiality provisions in the settlement I am unable to disclose facts and/or parties of the litigation.
- Settlement of multiple cases for amounts in excess of \$1 million dollars.
- Settlement of multiple cases for amounts less than \$1 million dollars.
- Represented over 150 clients that received diluted chemotherapy drugs. In the first trial the team obtained a \$2.2 billion verdict, which eventually led to a confidential settlement.
