REQUEST SUMMARY	Each County in Missouri is allocated federal funds to be used on local bridges for rehabilitation and replacement. Nodaway County has a need for additional off system funds and has offered to trade soft match credit for some of Jackson County's federal funds. The trading of funds is part of the program that MoDot oversees for the bridge program. This credit would be used by Jackson County in place of the 20% cash match required in the program. When using the credit, no match funds are required, the project is funded at 100% until the soft credit match balance is exhausted. The trade is set up for \$400,000 in credit for \$400,000 in federal funds. After the letter agreement is signed, it goes to Modot, who will do the accounting. Therefore, we request that the County Executive be authorized to execute the letter agreement.
