## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** amending the zoning districts established pursuant to the Unified Development Code by rezoning a certain 6.00± acre tract from District AG (Agricultural) to District RE (Residential Estates).

**ORDINANCE NO. 5464,** November 30, 2020

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) and "RE" (Residential Estates) Districts, so that there will be transferred from District AG to District RE a tract of land with a street address of 32700 E. Pink Hill Road, Jackson County, MO, legally described as follows:

A part of the Southwest Quarter of the Southwest Quarter Section 14, Township 49, Range 30, in Jackson County, Missouri, more particularly described as follows: Beginning at the southeast corner of the Southwest Quarter of the Southwest Quarter of said Section 14; thence along the south line of said Section 14, North 88 degrees, 38 minutes, 15 seconds West, 589.60 feet; thence departing said south lone of said Section 14, North 01 degrees, 39 minutes, 09 seconds East, 516.88 feet; thence South degrees, 38 minutes, 15 seconds East, 587.84 feet to a point of the East line of the Southwest Quarter of the Southwest Quarter of said Section 14; thence along said East line, South 01 degrees, 27 minutes, 23 seconds West, 516.88 feet to the Point of Beginning.

<u>Section 2</u>. The Legislature, pursuant to the application of Theresa Kramer (RZ-2020-593), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 5 to 0 to recommend <u>APPROVAL</u> of this application after a public hearing on November 19, 2020, does hereby adopt this

Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
