Request Summary

The 2021 Road Program was broken into four (4) bid packages. This is the second bid package. Public Works prepared plans and specifications, and Bid No. PW 02-2021 for roadway surface preservation using three (3) different techniques. The project includes 4.2 miles of fog seal to prevent water penetration and provide UV protection, 6.4 miles of scrub seal that uses brushes to push the sealant into the surface cracks with a fine aggregate applied to prevent water penetration and improve surface durability, and approximately 25.4 miles of crack seal to prevent water infiltrating the pavement subgrade. Advertisement was posted once in the Daily Record and the bidding information was posted on the "Public Purchase" Website.
