#### Introduction

Project/Title:

Appropriating \$50,000 to the indigent cremation account to correct the budget shortfall.

#### **Request Summary**

The 2021 budget anticipated a smaller number of cremations which did not come to fruition. Each year the county sees approximately 200 applicants a year. We are currently at approximately 90 cremations in 2021. The contract with our mortuary services charges \$655 per cremation. The county is reimbursed \$400 per cremation by the Greater Kansas City Community Foundation. After this amendment total funding will be \$106,000 for FY2021. Net fiscal impact for this additional appropriation to the county is \$19,600 in FY2021. There is an anticipated \$30,400 in revenue from reimbursements from the Greater Kansas City Community Foundation that will be allocated to 002-1525-47027.

The applications that are approved and denied are tracked through a Sharepoint excel sheet. Muehlebach Funeral Home also provides a monthly report. They are not attached, because of the personal information they contain.
