Requesting the County Administration to move forward with the development of a fleet maintenance
program and present to the Legislature a fleet maintenace plan for the acquisition, repair, and

maintenance of County fixed assets.

Request Summary

The FY 2021 Budget included over 2 million dollars to significantly increase funding for equipment replacement countywide. The Public Works Department was funded \$665,890 to fully fund a systemic replacement of its fleet. The Sheriff's Office was funded \$800,000 towards fleet replacement of their fleet of 100 vehicles on a five-year basis. Parks + Rec was funded \$450,000 to begin a systemic fleet replacement system for all Parks vehicles. \$100,000 was provided to the Assessment Department to begin a fleet for that department. Currently each department is repsonsible for its own fleet maintenance needs using various term and supply vendors. The Sheriff's Office has recently requested to use their funds in part to purchase 17 patrol vehicles.

This resolution is requesting the County Administration to develop a fleet maintainence program to manange the vehicles countywide and look at the cost of maintenance as well as a schedule for acquisition and replacement.
