Authorizing the County Executive to sign a commercial real estate contract and any other agreements necessary for Jackson County to purchase approximately 107.5 acres of land located at 7000 E. US 40 Hwy in Kansas City, Missouri from Park Holdings, Inc. in the amount of \$7 million for the purpose of acquiring a site for a new Jackson County Detention Center. Transferring \$7,050,000 within the 2021 County Improvement Fund for the land purchase and associated real estate closing costs.

Request Summary

This resolution authorizes the County Executive to sign a commercial real estate contract and any and all contracts necessary to purchase approximately 107.5 acres of land generally located at 7000 E. US 40 Hwy in Kansas City, Missouri from Park Holdings, Inc. of Wichita, KS for the purpose of siting a new Jackson County Detention Center. This resolution further authorizes the transfer of \$7,050,000 within the 2021 County Improvement Fund to fully fund this transaction inlcuding the land purchase and a portion of any real estate closing costs. Additional funds will be needed at a later date to accommodate the relocation of the existing tenants at the site.
