This ordinance seeks to amend Chapter 10 of the County Code to add procurement regulations for the acquisition of design/build contractors for county projects in excess of \$10 million of total cost. These new procurement practices will supplement existing capital project procurement requirements and will only be used for large projects in excess of \$10 million in total cost. It is anticipated that this design/build procurement methodology will be used by the County for the new Jackson County Detention Center. This codified procurement will replace Executive Order 94-24.
