5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Mike Sanders, County Executive, said staff will be giving an update on the H1N1 virus - swine flu at a later date.

He reminded everyone that there will be an open house today at 3:30 P.M. of the newly renovated Examiner's building. Jackson County was able to accomplish a tremendous amount of work at the Examiner's Building using our own trades personnel to finish off a garage area into office space for the Assessment Department. This allowed the upper floor to be renovated into new space for the Prosecutor's Bad Check Unit since they moved from 200 S. Main. By using Jackson County staff, with some minor contracted work, estimated savings to the county is in the amount of \$130,000. The employees that worked on the project were recognized for their efforts on Wednesday, May 6, 2009 as part of the Public Employees Recognition Day.
