5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Frank White Jr., submitted Jackson County's recommended balanced budget for 2017. The budget reflects a generally favorable economic environment as well as the inclusion of revenues approved by the voters in the November election, the COMBAT tax and the motor vehicle sales tax. He is pleased we can continue to provie the vital services that COMBAT provides for our community. Jackson County voters have demonstrated the value they place on insuring safe and healthy communities, including the voters passing the Children's Services Fund Tax. He thanked the County Legislature for their support and hard work helping our citizens understand the importance of the items on the ballot. As the County Legislature looks at the 2017 budget they will notice it includes the single largest increase to the Jackson County Department of Corrections budget in the history of this County. Jackson County is

housing over 100 more inmates per day in 2016, than two years ago. At the same time the cost to provide healthcare and other vital inmate needs continue to rise. We believe the investment outline in the 2017 budget will help provide the type of detention facility operations necessary for the safety of our community. Finally, with the support and approval of the County Legislature, Jackson County can plan to continue to invest in our Associates through increased contributions to Associates healthcare and an increase to the County's pension plan. In addition the 2017 budget includes a two-percent merit pool for County Associates to ensure that we continue to reward Associates who meet or exceed our expectations.

Frank White Jr. announced the Independence Square Lighting Ceremony will be held on Friday, November 18, 2016 starting at 5:30 P.M. There will be live holiday music, dance performances including the Quixotic Fire Dancers and the Kansas City Ballet Second Company, Kids Winter Wonderland with face painters and cookie decorating and a visit from Santa. He said we are honored to have a special guest, 2016 Olympic Silver Medalist Zach Garrett who is from Wellington, MO, who will light up Independence Square with a bow shot at 6:30 P.M.

treasury to the credit of the fund from which payment is to be made each sufficient to provide for the obligation herein authorized.
