### **K.C. Legislative Assembly Area, Kansas City, Missouri**

Scott Burnett, Chairman, called the meeting of the Jackson County Legislature to order.

**1 ROLL CALL**

**2 THE PLEDGE OF ALLEGIANCE**

**3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING**

A motion was made by Crystal Williams, seconded by Theresa Galvin to approve the journal of the previous meeting held on January 30, 2017. The motion passed by a voice vote.

**4 HEARINGS**

*Fred Dreiling, Chief Intergovernmental Relations Consultant, and Noel Torpey, assistant lobbyist, gave a summary of legislation discussed in Jefferson City, Missouri. Fred Dreiling stated that the right to work legislation passed and Missouri is now the 28th state to adopt the right to work. He said prevailing wage legislation is being discussed with regards to first class and charter counties.*

*Noel Torpey said he thinks House Bill 50 will pass this year. The bill relocates courts in the Sixteenth Judicial Circuit from Kansas City to Independence. He also mentioned that bills are now required to go through two Rules Committees which will slow down the adoption of legislation.*

*Fred Dreiling said House Bill 90 (Prescription Drug Monitoring Program) will have a hearing on Wednesday, February 8th and he will testify on behalf of Jackson County, Missouri since it is not currently in the*

*program. Dan Tarwater, County Legislator, said he will also testify.*

*Fred Dreiling reported that the stadium funding for Jackson County remained in the 2017 state budget.*

*Other legislation discussed was restoring state highways to local control, prisoner per diem rate, prohibiting the use of public funds for any stadium, Senate Bill 136 (\$5 user fee on instruments recorded with the Recorder of Deeds for an assistance program for homeless persons), and funding of 911 emergency communications services.*

*County Legislators asked questions and there was discussion on other legislation dealing with senior citizens, highways, real identification, corporate income tax and the performing arts center proposed for downtown Kansas City, Missouri.*

*Fred Dreiling's report to the County Legislature is attached.*

## **5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE**

*Frank White Jr., County Executive, said Constructing Futures gave away two houses in the Ivahnoe Neighborhood to two deserving families on February 2, 2017. He thanked legislators, Scott Burnett, Crystal Williams and Theresa Galvin for attending. He also recognized James D. Tindall Sr., Director of the Housing Resources Commission and Alfred Jordan, County Legislator and Chairman of the Housing Resources Commission, for their support on this project. Frank White Jr. also thanked Scott Burnett and Crystal Williams for their personal donations. He showed a short video taped on February 2 for those who were unable to attend the ceremony held at Ivanhoe Neighborhood Council located at 3700 Woodland in Kansas City, Missouri.*

*Frank White Jr. said since February is Black History month there will be an exhibit on the first floor of the Jackson County Courthouse in Kansas City, Missouri titled "A Place for All People".
