## 3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Dan Tarwater III, seconded by Dennis Waits to approve the journal of the previous meeting held on July 17, 2017. The motion passed by a voice vote.

#### 4 HEARINGS

Presentation by Jaime Masters, Chief of Health Services, gave an update on the Community Children's Services Fund. She said the board has met twice and their next meeting is scheduled to be held on Thursday, August 3, 2017 at 2:30 P.M. at the offices of the Mid-America Regional Council (MARC). They meet the first Thursday of each month at MARC. She said they are working on an RFP for funding by October 2017 and they have over \$2 million to date. They have a meeting scheduled with Jay Haden, Deputy County Counselor on Thursday, July 27th. She said Louise Cordoba is stepping down from the board due to a conflict of interest. There has been discussion about hiring a firm to search for an executive director. Alfred Jordan, County Legislator, asked for a point of contact. Jaime Masters responded that Rhonda Holman is the temporary chair and all questions should be referred to her.

Scott Burnett asked Jaime Masters to send a list of board members and meeting dates for the Community Children's Services Fund.

#### 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Frank White Jr., County Executive, thanked the County Legislature for funding the cell door locks at the jail.

Gary Panethiere, Chief Operating Officer, reported that the lock and cell door project at the jail is complete. He thanked the County Legislature, the current and past County Executives and the staff at the jail for their support.

Joe Piccinini, Director of Corrections, said the project caused displacement of 32 inmates since the jail has more inmates than beds. He thanked staff for effectively moving the inmates. He thanked Craig Mosher, Director of Facilities Management, for working with the contractor, Cornerstone Detention Products on this project. There were 488 door retrofitted and it was done in three phases. The cost was approximately \$2.8 million. He said he found a memo from 2007 from the projects manager who stated that the doors at the jail needed to be retrofitted. He was happy to report in 2017 that the project has been completed.

Dan Tarwater II, County Legislator, said he asked the County Executive about a report regarding the pension plan for sheriff deputies last week and was informed that the pension board would meet again in August. He said he requested and received a copy of the draft report today and noticed that the Administration has had the draft since June 14, 2017.

Frank White Jr. responded that he has not seen the draft but is aware that Gary Panethiere, Chair of the pension board, will discuss it at the next meeting scheduled to be held on August 24th.
