Dennis Waits, County Legislator, said two weeks ago the County Legislature made it known that they were not happy with the process used for the selection of the COMBAT Director.

Dan Tarwater III, County Legislator, said a national search for the COMBAT Director position should be completed by the end of November.

Dennis Waits said elected officials should be included in the selection process and should not be replaced with associates from the County Executive's office.

Crystal Williams, County Legislator, said she is not in favor of giving up the rule regarding the County Legislature's consent with regards to County Executive Orders as stated in the Jackson County Charter.

Tony Miller, County Legislator, said he was fortunate enough to be a part of the process when Jim Kanatzer left his seat as the Prosecuting Attorney to become a judge. He asked that everyone reflect on that process collectively.

14 NEW BUSINESS

Matt Brillhart, County Program Director, invited members of the County Legislature to attend the Jackson County Leaders Breakfast on Thursday, October 12, 2017 from 7:30 a.m. - 9:00 a.m. at 105 E. 5th Street, Kansas City, Missouri. The breakfast is hosted by MU Extension - Jackson County with Honorary Chair, Alfred Jordan and special guest, Dr. Marshall Stewart, Vice Chancellor for MU Extension and Engagement, who will share what MU Extension learned from the Jackson County and statewide Community Conversations. Dr. Stewart will detail how MU Extension is using the feedback to prioritize programming efforts and address community needs moving forward.

Dennis Waits, County Legislator, said there has been talk about a downtown

baseball stadium. He requested a financial advisor be invited to speak to the County Legislature and Administration about the ramifications. The cost of a downtown baseball stadium is estimated between eight hundred million and one billion dollars and this figure does not include parking. He agreed we need to continue to update our current stadiums. However, since the jail is in crisis mode, he believes the focus should remain on the jail and not the stadiums. Dan Tarwater III agreed with him.
