3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Jalen Anderson, seconded by Crystal Williams to approve the journal of the previous meeting held on March 11, 2019. The motion passed by a voice vote.

5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

No reports from the County Executive.

Scott Burnett, County Legislator, asked Jay Haden about the article written by Mike Hendrix regarding the freedom of information request from the Kansas City Star pertaining to the testimony in front of the grand jury. Jackson County refused to give the documents. As a result the case went to court and the judge ruled in favor of the Kansas City Star. So Jackson County had to turn over the documents and pay legal fees in the amount of \$13,400.00. He asked why the County Legislature was not informed about the lawsuit and the judgement.

Jay Haden, Interim County Counselor, said he was not involved in how it was initiated. He said the Prosecuting Attorney or the Circuit Court had custody of the documents, the County Counselor did not. The Administration believed the documents were covered by grand jury secrecy rules. The Prosecuting Attorney's office disagreed. Under Steve Nixon's direction, Jackson County filed a lawsuit against the Kansas City Star to challenge whether or not they were open records. The Judge decided the County Administration and County Counselor's office did not have standing to raise the issue. State law allows the Kansas City Star to draw their attorney fees. Jackson County Code authorizes that once reduced to judgement, the payment could be made without the County Legislature's approval.

Tony Miller, County Legislator, said the judgement is self executing.

Jay Haden said because it is self executing, it did not have to come before the County Legislature for payment. He said this lawsuit was handled in house.

Discussion regarding settlements and judgements.

Tony Miller asked the County Counselor to advise the County Legislature of these types of judgements in the future.

Ronald E. Finley, County Legislator, asked Jay Haden to email him the case number. He also asked Jay to distribute the opinion from Stephen Nixon regarding the Reports of the County Executive. Jay Haden asked Mr. Finley for additional information as he did not recall such an opinion. Mr. Finley agreed to discuss it with him after the meeting. Jay Haden said if the opinion is in writing he will distribute it.

Theresa Galvin said after the legislative meeting last week she received a call from County Executive Frank White Jr. and he stated that he would not answer any more open questions in this forum. He wanted questions or comments to be noticed up under Hearings on the legislative agenda. She shared this request with other legislators. She said as legislators they have a duty and right to represent their constituents and they will ask questions in an open forum if needed. She will not stop any legislator from doing their job. It is the County Executive's decision not to answer and she will respect his decision.

She acknowledged Sheriff Forte in the audience.
