## 8 **RESOLUTIONS IN COMMITTEE**

Lauren Palmer, Director of the Local Government Services Department for the Mid-America Regional Council (MARC), was present to answer any questions. She said the Administration asked MARC to give a proposal with regards to Resolution #20094. She said the largest costs are for legal services and community/public engagement events. She said MARC is a neutral facilitator and the proposal is based on one idea of how to approach this process. She said the largest sum in the contract is for marketing and setting up public meetings. A large part of the work is in digesting input and reporting back to the commission.

Dan Tarwater III said he was disappointed to learn that the Prosecuting Attorney said MARC was not helpful with providing assistance facilitating the selection of a Director for COMBAT.

Lauren Palmer said she began working for MARC after that time and had no knowledge of this incident. She said she would speak with others at MARC about what happened at that time.
