Theresa Galvin, Chair, called the meeting of the Jackson County Legislature to order.

#### 1 ROLL CALL

## 3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Dan Tarwater III, seconded by Scott Burnett to approve the journal of the previous meeting held on April 01, 2019. The motion passed by a voice vote.

#### 4 HEARINGS

Troy Schulte, City Manager for Kansas City, Missouri, and Donna Maize, Assistant City Manager for Public Safety, addressed the Legislature.

Troy Schulte said that the City of Kansas City was there to gauge if there was any interest by the County in pursuing an agreement whereby the City would lease the space at the Regional Correctional Center (RCC) for up to one year until the City could complete its own jail facility for the housing of approximately 80 to 100 detainees. He said that the City would staff the facility with police department officers and pay all costs for housing the detainees. The City is seeking the RCC space for lease at a market rate. Troy Schulte said that they City had found alternative housing for the City's sentenced inmates, but for efficiency and logistical reasons, using the RCC location is a good centralized solution for holding these detainees.

Frank White Jr., County Executive, thanked Mr. Schulte for appearing at the Legislative meeting. He stated that this was the first he'd heard of this proposal and would have to give this plan some additional thought. He said that Sheriff Forte' has control of the jail and that they both share concern for the safety of the people at the jail.

Theresa Galvin, Chair of the Legislature, said that she thinks it is in our best interest to work with our neighbors in a partnership for a regional jail solution. She said that in looking at the Charter it says that the Sheriff is responsible for the County inmates at the jail, not those City detainees at the RCC. Additionally, the Legislature has control and power to rent and lease properties in the County. She said she would lead the charge in pursuing a plan to find a compromise on this issue.

Dan Tarwater III, County Legislator, said that he understands that the time for a regional combined jail may have passed. But, he said, the Administration has stated that they plan to mothball this space. The convenience for this location for detainees that will bond out quickly makes this a logical solution.

Crystal Williams, County Legislator, asked what would be the downside to leasing this space to the City, given that they intend to assume costs, maintenance, and all expenses. We need this partnership with the City, even as we move forward with a new jail facility. Crystal Williams said she does not think that holding detainees at the patrol stations is in the best interests of the citizens of Kansas City.

Jeanie Lauer, County Legislator, asked Mr. Schulte about the City's plans for a permanent jail for all of the City's sentenced inmates and detainees. He said that they are looking to operate about a 440 bed facility. He said the RCC gives them more flexibility and a centralized holding location.

Jay Haden, Interim County Counselor, said that the Charter does authorize the Legislature the power to lease vacant space and if the Sheriff's intent is to mothball this space, then that becomes important. If the Sheriff has another use for this space, then he doesn't think the Legislature has the authority to lease space without the consent or recommendation of the Sheriff. Theresa Galvin asked if the County is actually using this space because it is her understanding that the City is currently leasing the facility.

Sheriff Darryl Forte' said that his primary concern was for a contingency plan if they had to move inmates from the jail in the case of an emergency. He read from the grand jury report related to the jail. He asked, why would the County want to rent out a facility that is seen as one of the worst jails in the country? The Sheriff said that citizens are not distinguishing between the RCC and the jail as a whole. He said we need to use this space for programs. He said he is concerned about the perception of how we treat people. He said that if there was a disaster, they would need the space. Sheriff Forte' said that reduced numbers of inmates at the jail would help them do what needs to be done to ensure the safety of the detainees.

Scott Burnett, County Legislator, said that if we are going to use this space for programs, he does not see how the space then can be used for housing inmates. He said, they have been told that the County cannot take state charged inmates into the RCC space because it is not adequately secured for those inmates.

Diana Turner, Director of the Department of Corrections, said that the DOC has offices on its fifth floor for population control and mental health professionals. She said that the Department does need to use this space.

Theresa Galvin said that this discussion needs additional exploration and is a topic the Legislature will need to act on quickly.
