Theresa Galvin, Chair, called the meeting of the Jackson County Legislature to order.

2 THE PLEDGE OF ALLEGIANCE

3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Dan Tarwater III, seconded by Crystal Williams to approve the journal of the previous meeting held on April 15, 2019. The motion passed by a voice vote.

4 HEARINGS

Pamela Allison, CPA, CFE, of the Missouri State Auditor's Office, said they will begin working on the Jackson County procurement practices audit. The scope of the audit will cover the contracting and procurement processess. The cost of the audit, as mentioned in the engagement letter, will be between \$200,000.00 and \$500,000.00. Also in attendance were Todd Schuler, CPA and Audit Manager, Bob McArthur, Senior Auditor III of the Public Corruption and Fraud Division, Rex Murdock, staff auditor and Tessa Rusatsi, CPA, Senior Auditor III.

Bob McArthur said the COMBAT audit started in January. It is a separate engagment letter with a cost of between \$35,000.00 -\$50,000.00 as quoted previously. Ms. Allison said that she expects the COMBAT portion of the audit to be completed soon.

Ronald E. Finley, County Legislator, asked about the actions in 2018 that began the audit process. He asked Bryan Covinsky, County Counselor, to

send him all legislation and documentation pertaining to the request to the State Auditor for a performance audit of Jackson County, Missouri.

Ms. Allison said that the audit will cover the best practices, internal controls, and compliance with State and County laws. The auditors will make recommendations as they go along in the process. She said that whenever the auditors find an area of concern they will make an immediate report, so corrective action can start. She said more information about the types of audits they perform can be found at www.auditor.mo.gov.

Scott Burnett, County Legislator, expressed concern about the cost of the audit. Ms. Allison said those costs were determined based on estimates from similar sized counties with similar audit scopes. She said they would review this cost estimate with her supervisor and the Missouri State Auditor.

Ms. Allison said that it is their practice to review their final report in a closed session with the Legislature before making the final report public. She said the Legislature and the County Executive will have the opportunity to issue a response to the report.

Rob Whitten, Executive Director and Jovanna Rohs, Chair of the Jackson County Community Children's Services Fund were present and distributed a handout for their powerpoint presentation. (Copy of handout available in the office of Mary Jo Spino, Clerk of the County Legislature.)

Scott Burnett asked about where most children served by the Children's Services Fund live. Mr. Whitten said that their presentation lists the ZIP codes where most of the children served live. Mr. Burnett asked for information about those agencies that are based within these key ZIP codes.

Dan Tarwater III, County Legislator, asked about the types of programs funded by the Children's Services Fund. As an example, he asked what program was funded for Children's Mercy Hospital. Ms. Rohs said that the program at Children's Mercy is a home visit program for children who are identified as at risk for child abuse. Studies have shown that child abuse can be reduced through education and home visitation programs. Ms. Rohs said that the agencies must list three outcomes for their programs. In the agency reports, they must demonstrate how the program is performing based on these projected outcomes. *Ms.* Rohs also discussed their committment to working with schools within Jackson County through collaboration and in partnership with community-based agencies to provide the needed services.

Dennis Dumovich, Director of Human Resources, said the health insurance RFP should be ready by April 30, 2019 to send out. He said responses are due May 30th and the award date will be mid-July. Open enrollment will begin in November.

Dan Tarwater III, said most insurance carriers want 60-90 days to prepare quotes. He suggested Human Resources extend the time to get more responses.

Dennis Dumovich said they have time and they will do as suggested by Dan Tarwater III.

With regard to the compensation study, they are in discussions with Evergreen Solutions to get that agreement finalized.

Mr. Dumovich said they are not recommending any changes to the services provided by the dental and medical coverage. He will still continue to use the existing insurance broker. He said they have separate brokers for dental and medical insurance.

Scott Burnett, County Legislator, asked Whitney Miller, Director of Collections, to speak to the County Legislature about the new mobile and web-based payment system that will make it easier for taxpayers to make property tax payments. The new system is called "myJackson County." Ms. Miller said she sent out an email today to legislators and staff. She said there will be a press release tomorrow and the website will be redirected. She said taxpayers can use home and mobile devices and all types of credit cards. She said the fees have increased and the fee for ACH is \$1.25, but Jackson County does not receive any convenience fees. She said the system will be down from 6:30 p.m. tonight until 7 a.m. Wednesday morning. She explained they are doing it now because they wanted to test a higher volume with it being tax sale time.

Scott Burnett asked if this system was competitively bid.

Whitney Miller explained that this is the only vendor who will work with our current ASCEND software.

Theresa Galvin asked that all legislators receive the cards for this new system. Whitney Miller distributed them at the meeting.
