Theresa Galvin, Chair, called the meeting of the Jackson County Legislature to order.

## 3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Dan Tarwater III, seconded by Crystal Williams to approve the journal of the previous meeting held on November 04, 2019. The motion passed by a voice vote.

## 4 HEARINGS

Theresa Galvin, Chair, introduced Whitney Miller, Director of Collections, to present information regarding the 2019 billing season.

Ms. Miller said that a list of frequently asked questions is posted on the Jackson County website. She said that the process to generate tax bills for mailing is completed. It takes approximately a month to prepare tax bills for mailing. The first mail drop will be sent on Tuesday, November 12, 2019 and will continue through Thanksgiving. About 60,000 bills will be mailed each day. All bills should be received by taxpayers by December 1, 2019. If a taxpayer does not receive a bill, by state law, that does not change their obligation to pay. Taxpayers may check the amount of their tax bill online and taxpayers are encouraged to pay online to avoid long waits. Ms. Miller said that as it gets closer to the end of the year the wait time will increase. The Collection Department has added Saturday hours from 8 a.m. until noon during December at its Independence location.

Jackson County Courthouse 415 E.12th Street, 2nd floor Kansas City, Missouri 64106 (816)881-3242 Ms. Miller said that if a taxpayer has a pending Board of Equalization (BOE), State Tax Commission (STC) appeal or an informal review of their taxes, the Collection Department will adjust bills as guickly as possible and issue a new bill to taxpayers. Ms. Miller said that in accordance with state law. tax bills are due by December 31. If there is a BOE or STC adjustment after a taxpayer has paid their bill, the Collection Department will automatically issue a refund of the overpayment. There is no requirement that a taxpayer pay under protest to receive a refund or to preserve their right to appeal. She said that the second adjusted bill will be stamped in red ink that says, "ADJUSTED BILL" and will arrive with a cover letter from the Collection Department. Ms. Miller said that the billing timetable has been on the exact same schedule as in previous years. Their goal is to have tax bills delivered by December 1 to give taxpayers thirty days before the bills are due. Ms. Miller emphasized that if a taxpayer does choose to pay under protest, the timeline for issuing a refund may be delayed.

Scott Burnett, County Legislator, asked about options for taxpayers who cannot pay their bill in full. Ms. Miller said that the Collection Department will receive partial payment of real property taxes in person or by mail. She said that penalties and interest will accrue on the unpaid balance beginning January 1, 2020.

Crystal Williams, County Legislator, asked Ms. Miller if the Legislators have any recourse to assist their constituents with these hefty bills. Ms. Miller said that she appreciates the gravity of the situation for some taxpayers, but her office has little leeway on the issue of values or the amount of the tax bill. She said that is an issue between the taxpayer and BOE. Any taxpayer caught off guard by the amount of their tax bill may write a letter to the BOE to request a late appeal. The BOE website has a list of frequently asked questions about the appeal process.

*Mr.* Burnett asked how long it will take for a taxpayer to receive their refund after an adjustment. Ms. Miller said that there are many factors that will determine how long it will take to receive refunds, depending on the BOE hearing schedule and the number of refunds issued. She will keep the legislature updated as information changes.

*Ms. Miller* said that she wants to stress that the Collection Department processes 520,000 billing accounts and less than 5 percent of those accounts are in the appeal process. It is the Department's goal to provide all taxpayers the same customer service regardless of the taxpayer's account status. She asks for everyone's patience with the process.
