Theresa Cass Galvin, Chairman, called the meeting of the Jackson County Legislature to order.

#### 3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Dan Tarwater III, seconded by Tony Miller to approve the journal of the previous meeting held on January 27, 2020. The motion passed by a voice vote.

#### 4 HEARINGS

Ronald E. Finley, County Legislator and Dawn Hickman, Legislative Aide, presented Resolution #20363, adopted at this time, to the family of Rev. Wallace S. Hartsfield. See page 4 for details.

Troy Schulte, County Administrator, presented information regarding the review of the assessment process. He said that there were 21,208 appeals filed with the Board of Equalization. The BOE and Assessment Department resolved 7,799 appeals by December 31, 2019. Their goal is to resolve all appeals by March 31, 2020. Approximately 98% of all residential appeals requested less than a 10% increase. The BOE has granted the taxpayers' requests in about 70% of the appeals. As of result of the large number of appeals, the Collection Department is behind in billing and he anticipates some constituents to express concerns about that lag time.

Mr. Schulte said that there were a number of lessons learned from the 2019 reassessment process, including problems with understaffing, out of date software, issues with physical inspections, and over reliance on consultants and computer models. He said the key to a successful 2021 reassessment will be to get an early start on the process, fix staffing issues, and work on technology upgrades, as well as improving all levels of communication with the community, legislature, and all key stakeholders.
