2 THE PLEDGE OF ALLEGIANCE

3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Dan Tarwater III, seconded by Charlie Franklin to approve the journal of the previous meeting held on June 01, 2020. The motion passed by a voice vote.

4 HEARINGS

5 COMMUNICATIONS WITH AND REPORTS OF THE COUNTY EXECUTIVE

Frank White, Jr., County Executive, made a statement to the Legislature. Mr. White said the prior Legislature elevated him to this position because of their confidence in him. Since that time, he feels many things have happened to discredit his administration rather than work with him to get things done.

He said he has been blamed for problems at the jail, even though those problems existed before his administration. He said moves to change the County Charter have been made to take away his power to appoint directors and interim directors and to limit his veto power. Mr. White added acts to defund positions within his Administration caused the loss of some staff. He believes this has impeded his ability to hire quality staff. He said there have been unwarranted negative press against his Administration. He said this is a respect issue by this body for his Administration. He said the Legislature called an emergency meeting and he was not notified. He found out about the meeting from the Sheriff's Office while handing out food. He said he did not know why this meeting was called or what was to be on the agenda. Mr. White said this goes back to respect, respect for him as a person, and respect for the County Executive's Office. Mr. White said he was voted into this office and he has earned this title. He believes there has been a strong desire by this Legislature to take administrative duties away from the Administration and move power to the Legislature. He said they are two co-equal branches of government. He said they should move simultaneously and should respect each other's responsibilities.

Mr. White said when the County received the CARES Act funds, there should have been an overwhelming positive reaction. He said this would be an opportunity for the County to do something meaningful in the community. He said instead the first response from the Legislature was to say they wanted total oversight, as if this Administration cannot be trusted to do its job. Mr. White said this is offensive to his Administration. He said the Legislature wants to be able to move dollars without consulting his Administration. He said the County Code says they are co-equal branches of government and must move simultaneously.

Mr. White said the Advisory Committee is made up of reputable people from the community who are excited to make an impact in the community. Mr. White said he heard there is a movement to disapprove the appointment of this Advisory Committee. He asked if this is disapproved, then who is going to do this work to reach out to the community. He said these are top quality people to give top quality advice. He said he does not want his Administration to be cast as people who cannot get the job done. He said let the Administration's staff bring measures to the Legislature, as the policy makers for the County, and the Legislature can vote those measures up or down. He said he wants the respect of the Legislature to let them get his job done. He requested that the Legislature reconsider voting this down. He said, the Advisory Committee has completed three weeks of work. The Administration believed having an Advisory Committee was a great way to be transparent. He said he is disappointed. He said Jackson County needs to let the community know we are working toward making progress together.

Mr. White said he is a big advocate and supporter of Truman Medical Centers, both with funding in the budget and support through charity golf

tournaments. He is not opposed to funding to help TMC, but he is opposed to the way this was done today. He said he wished the Legislature would consider working together with the Administration as we move forward to work to help our community.

10 INTRODUCTION OF PROPOSED ORDINANCES AND ASSIGNMENT TO COMMITTEE

Theresa Cass Galvin. Chairman. read a statement regarding Ordinance #5354. She said over the past couple of weeks, the County has seen large gatherings not practicing social distancing or using PPE. It will only take one person in one of those crowds to be positive for COVID to spread like wildfire and it probably has, people just have not shown symptoms yet. Yesterday Mayor Lucas announced 200 cases that can be traced back to a paper company in Kansas City. The County Executive has told the Chairman that the County needs to be prepared for the second wave of COVID cases expected this fall. Ms. Galvin said she initiated this ordinance because Truman Medical Centers (TMC) is our public health system and through no fault of their own, they are not prepared for what lies ahead. This ordinance would allow them to start the process of ensuring the safety of health care workers and the people of Jackson County. Ms. Galvin said she was told yesterday that this cannot be appropriated without the County Executive's approval and he would not approve it because he does not agree with it.

Ms. Galvin said she called the County Executive this morning and asked why he was not approving this ordinance. From what she gathered from the conversation, the County Executive does support TMC, however, he didn't like the way the Legislature went about it, saying the Legislature is excluding the Administration and there isn't enough respect for the Administration. Ms. Galvin said she was sorry he felt that way. That was not her intention or the intention of anyone on the Legislature. Also, he said, the Administration needed more clarification and there was no vetting. On May 14th there was a Zoom meeting with TMC, and the Administration was present. On May 26th TMC made a presentation at the Legislative meeting under Hearings, the Administration was present. On May 27th TMC presented once again in a Zoom meeting, the Administration and the advisory group were present. On May 29th, TMC had another Zoom meeting, the Administration was present. Ms. Galvin said she really does not know what more TMC could have done. She said she thinks it is sad that egos are getting in the way of the greater good of the people of Jackson County.

Ronald E. Finley, County Legislator, said he understands and appreciates the County Executive's statement. He respects the fact that the County Executive came here to make his statement. He said he wishes the County could do what it can to get together. The intent of this Ordinance with TMC is a good intent. This is a large amount of money. It is needed. It has been discussed. He said he understands the Chairman's concerns about getting something done because people are sick and dying. The County needs to try to move ahead together. He said he respectfully suggests this be mediated to find a solution on how to proceed. Mr. Finley said the Legislature was promised more information as stated in the order itself. Before the Legislature and the Administration start a fight, they should try to settle this matter. This funding measure is important. Mr. Finley said he would like to have the opportunity to visit TMC to see what kind of capital improvements they are requesting. He would also like to see consideration of the request by Kansas City, Missouri. He said he is prepared to support this Ordinance.

Discussion.

Dan Tarwater III, County Legislator, said that this action is not giving TMC this money upfront. It is appropriating these funds into an account from which TMC can request reimbursement as work is completed. This will make sure the funds are there for the County hospital.

Ronald E. Finley said with recent gatherings he would like to place the health department reports in the record. He said research indicates that today in Eastern Jackson County there have been 20 deaths. In Kansas City, MO 1,183 persons have been infected with COVID and there have been 27 deaths. The Kansas City Health Department reports 109 hospitalizations. The total number of persons tested in Kansas City, MO is 26,009.

Dan Tarwater III said we are all appalled by the murder of George Floyd. People have forgotten that COVID-19 is still present. He said there are people protesting right next to people without masks. He said he is concerned about these numbers increasing.

Theresa Cass Galvin asked Mr. Finley if the reports included the number recovered. He said they did not.

Theresa Galvin asked to reconsider Executive Order #20-07.
