Theresa Cass Galvin, Chairman, called the meeting of the Jackson County Legislature to order.

1 ROLL CALL

2 THE PLEDGE OF ALLEGIANCE

3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Dan Tarwater III, seconded by Scott Burnett to approve the journal of the previous meeting held on June 08, 2020. The motion passed by a voice vote.

4 HEARINGS

Eileen Weir, Mayor of the City of Independence, addressed the Legislature regarding the distribution of CARES Act funds. She said the County was given this allocation 53 days ago to provide assistance to County residents who are sick, dying and depending on their local government to provide assistance.

Mayor Weir said each Tuesday County Administrator, Troy Schulte hosts a call with Jackson County mayors, city administrators, and city managers. Throughout these calls we have attempted to discern the process required to obtain a portion of CARES Act funds. County Executive Frank White began hosting calls May 19 at the request of area mayors. A clear, transparent, equitable process to request funding has not been developed. A new process and new sets of rules have been introduced nearly every week absent any input from the Jackson County municipalities. Initially Troy Schulte instructed the city officials to provide him with their requests which would be reviewed and submitted to the Legislature for consideration. City officials had asked for a template to use in submitting requests. Initially Mr. Schule said that would be developed. Then Mr. Schulte said he was preparing a request for proposals to engage a consultant to act like an escrow agent. Next, County Executive Frank White announced an advisory group. Troy Schulte said the advisory group would review certain applications, but the city requests would be reviewed by the County Administrator. When Jackson County mayors submitted the same question to the County Executive, they were told the advisory group would review all of the requests. Mayor Weir said the City was told their two requests would be on today's agenda. It is not. Last week the County Executive released a statement that he now wants to release funds based on population, after having previously said he would not support a funding allocation based on population.

Mayor Weir said this process changes week to week and sometimes day to day. She said it is impossible to conduct business under these conditions. Developing and implementing a clear plan is long overdue. By her count, at least seven different plans have been articulated. She said that until a single plan is developed, Jackson County is failing to meet the needs of its citizens.

Ron Finley, County Legislator asked if Mayor Weir had any input on the plan offered by the County Executive last week. Mayor Weir said she has declined to support the County Executive's plan.

Crystal Williams, County Legislator, commented that the Legislature has been advised by the County Counselor's Office that as Legislators, they do not have the authority to direct these disbursements. This process must go through the County Executive's Office.

Theresa Cass Galvin, Chairman, said the Legislature has oversight of how the funds are spent.

Dan Tarwater III, County Legislator, said the Legislature would also like to have these requests submitted for approval. These funds have certain requirements and restrictions. The Legislature wishes this were handled more quickly as well.

Discussion.

Presiding Judge David Byrn said there continue to be leaks in the building. He said the most recent leak was on the 8th floor. He said the condensation pipes in the building are old and clogged and every

summer when the air conditioning comes on, the County has this issue. It is his understanding that the Administration is developing a request for proposals to fix this issue.

5 COMMUNICATIONS WITH AND REPORTS OF THE COUNTY EXECUTIVE

Frank White Jr., County Executive, said in response to Mayor Eileen Weir's comments, these issues were being worked up until the Advisory Group Executive Order was voted down. The members of the Advisory Group resigned, stating they did not want to be in the middle of a political process. These issues have slowed down the process. The County Executive's office is in regular contact with city officials. Despite Mayor Weir not being on board with a proportionate allocation, the other mayors in Jackson County are in support of that proposal. He said he does not have the staff to handle all of these issues. He said he is disappointed they have been unable to get on the same page.

Crystal Williams said that as the Budget Committee Chair, she is frustrated by a situation that is the absolute purview of the County Executive's office, but if something happens it is the Legislature's fault. She said she believes the proportionate distribution of funds is the best option.

Scott Burnett, County Legislator, said that he understands there is agreement on the allocation based on population. Frank White said his office was working on getting an Ordinance prepared for next week.

Discussion.

Frank White added that Jackson County has been working with the Fox 4 LOVE Fund for a food distribution program. Anyone needing fresh produce can go to the Sheriff's Office on Wednesday, June 17 from 10 a.m. until 2 p.m. for distribution of food for the first 500 people. Everyone is welcome to volunteer to assist with the distribution of food.
