6 PERFECTION OF PROPOSED ORDINANCES AND REPORTS OF COMMITTEE

5414 AN ORDINANCE transferring \$3,200,000.00 within and appropriating \$13,175,267.00 from the undesignated fund balance of the 2020 County Improvement Fund, transferring \$1,503,198.00 within the 2020 Assessment Fund, and awarding a contract on Requests for Proposals Nos. 69-19, 1-20, and 2-20, for the furnishing of maintenance of assessment data, a computerized mass appraisal system, and reassessment services, all for

The County Legislature will have a public hearing regarding Ordinance #5414 on Monday, October 19, 2020 at 10 a.m. in the Kansas City Legislative Assembly Area.

Gail McCann Beatty, Director of Assessment, answered questions regarding the Ordinance. Ms. Beatty said the Assessment staff has been working on 2019 and 2020 appeals, STC appeals and out in the field working on new construction and permits. This proposal is the culmination of three requests for proposals for annual maintenance, reassessment, and a CAMA system. Ms. Beatty said she is asking the Legislature to invest in the Assessment Department in an amount that other counties spend in a typical year. In St. Louis County the average spent is \$37 per parcel. In St. Charles County they spend \$33 per parcel and Jackson County spends \$21 per parcel. This proposal is to bring the department to a higher level. This is a way to get the department on solid footing. She said they want to get started as soon as possible.

Dan Tarwater III, County Legislator, asked if there were other vendors that submitted proposals. Ms. Beatty said the annual maintenance part had three vendors apply. One vendor did not have much experience and another vendor was out of town in a smaller market. It was believed that the other two vendors could not handle the scale of the project. Ms. Beatty said she would send out specifics on the vendor scores. Ms. Beatty said the entire state of Kansas uses a different Tyler Technology product. Tyler also supplies assessment services for St. Louis County, Greene County, and Jasper County.

Theresa Cass Galvin asked about the discount provided by Tyler. Ms. Beatty said this price was Tyler's best and final offer. Ms. Galvin asked why this process took so long. Ms. Beatty said they have a shortage of staff. They started this process a year ago. The RFP bid process was extended and once the packets were distributed, COVID hit which put the process on the back burner. The evaluation process included the Assessment, Administration, Finance, and IT Departments. One vendor took themselves out of the running because of their workload.

Theresa Cass Galvin asked about some inconsistencies with Ordinance #5415. She said the back up states that there will be funding for laptops and scholarships, but the scholarship piece is not referenced in the ordinance. She asked Troy Schulte, County Administrator, if scholarships would be covered by CARES Act restrictions. He said he believes these would be covered. Carrie Coogan, Deputy Director of Public Affairs & Community Engagement with the Kansas City Public Library, said this scholarship proposal is for a program called Career Online High School, an accredited high school program for adults that have dropped out of high school. This request is for 15 laptops and 50 scholarships for online high school. Additionally, the budget page in the back up was cut off, so it was not possible to see the complete information. Jay Haden, Chief Deputy County Counselor, said they would have an update to the ordinance. A motion was made by Dan Tarwater III, seconded by Ronald E. Finley, to hold Ordinance #5415. The motion passed by a voice vote.

Swope was able to complete the testing but needed the lab work covered. This is the emergency contract that was put in place. The County needs to complete the widespread testing at the jail, but this will be fixed going forward.

Ronald E. Finley requested a moment of silence for Alex Harris who passed away this week. Mr. Harris was active in minority construction trades industry. Theresa Cass Galvin said the upcoming Walktober event will be held at Indian Creek Trail at 99th and Holmes. This Sunday's event at Berkley Riverfront Park was a success.

Theresa Cass Galvin announced that Gene Morgan passed away this week. Mr. Morgan had served for many years on the COMBAT Commission. She asked that everyone keep his family in their thoughts and prayers.
