13 UNFINISHED BUSINESS

Crystal Williams, County Legislator, said she hopes the Children's Services Fund Board remains non-political. She is concerned that the current appointee is planning to run for county office in the next election cycle.

Ronald E. Finley, County Legislator, said there will be a vaccine event on Friday and Saturday, March 19 and 20, 2021 at Arrowhead Stadium. There are 3,000 doses of vaccine for each day. The National Guard and the Jackson County Health Department will participate in this event. Currently, the Jackson County Health Department has a back log of approximately 120,000 citizens waiting for an appointment. Other vaccine events will be held at John Knox Village in eastern Jackson County and Morning Star Family Life Center will receive 2,000 doses of the vaccine this week. Mr. Finley hopes the County will use communication tools to encourage people to get vaccinated. He would like an update next Monday from Troy Schulte, County Administrator, on the County's pandemic response.

Scott Burnett, County Legislator, said Whitney Miller, Director of Collections, sent him and Dan Tarwater III an email with answers to the questions he asked during last week's legislative meeting. He said his legislative aide will forward the email to all legislators.
