Dan Tarwater III, Chairman, called the meeting of the Jackson County Legislature to order.

1 ROLL CALL

2 THE PLEDGE OF ALLEGIANCE

3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Scott Burnett, seconded by Theresa Cass Galvin to approve the journal of the previous meeting held on March 29, 2021. The motion passed by a voice vote.

4 HEARINGS

Resolutions #20649 and #20645 were adopted at this time. See pages 5 and 6 for details.

Doug Cowan, President and CEO of the Community Services League (CSL), and Jim MacDonald, Chief Community Impact Officer of the United Way of Greater Kansas City, presented information regarding the emergency rental assistance program. Mr. Cowan said CSL opened the application process in both English and Spanish on April 5, 2021. In this first week of operation, they have received 319 inquiries to receive assistance. Mr. Cowan gave an example of a problem identified as a result of a request from a woman for \$28,000 in assistance. Her rent delinquency was \$800 per month for the past year, but the late fees imposed on her account increased her delinquency nearly three-fold. They are providing professional assistance in this situation including attorneys to provide aid to navigate her lease issues. This assistance will

help stabilize the housing situation. In the first week of operation, they have received 319 requests. Of these requests, five percent are from Blue Springs, seven percent from Grandview, 57 percent from Independence, 12 percent are from Kansas City which will be referred to the City of Kansas City program, eight percent from Raytown, six percent from Lee's Summit, and five percent from the remaining smaller cities in Jackson County. The requests so far have been for \$205,000 in utility assistance, averaging \$806 per application, and \$370,000 in rental delinquent assistance, averaging \$1,451 per application. The law allows the payment of current month's rent and two forward months, so \$2,475 is the average request for rental assistance. In more than seven days of the portal being open there have been \$1.2 million in assistance requests. CSL has added nine dedicated staff members to assist with this labor-intensive program. One staff member is bi-lingual. Mr. Cowan said the process is labor intensive to be in compliance with the rules and regulations of the act. Approximately 16 percent of the 319 applications are in some level of eviction process.

Jim MacDonald said United Way is working to prevent evictions for residents that have been sued by landlords for back rent. Generally, tenants do not have legal representation when they are sued for back rent. The \$1.5 million in CARES Act funds is being used to provide legal representation, which typically provides a positive outcome for tenants. This program will help families keep their homes through rental assistance and legal representation. Once a renter is in legal eviction, the process can move quickly and the amount in arrears is beyond what is normally available through traditional assistance programs. This program is in collaboration with Legal Aid of Western Missouri, the Heartland Center for Jobs and Freedom and the University of Missouri – Kansas City School of Law with seven or eight attorneys working to fight evictions downtown and in Independence. They are able to pay back rent and current rent with the average assistance of about \$3,000.

Charlie Franklin, County Legislator, asked if there are differences in the program for families with children and those without children. Mr. Cowan said they provide assistance to all family situations. Mr. Franklin asked about people who offer to complete the rental assistance application for a fee. Both Mr. Cowan and Mr. MacDonald said they had not heard of situations in which people were being charged a fee to provide the service. The United Way and CSL staff will provide tenants with assistance in completing the application so no one should be paying for that service.

Jeanie Lauer, County Legislator, asked if the funding assistance is given

directly to the tenant. Mr. Cowan said normally the assistance is paid to the utility company or the landlord, but the law does provide in certain circumstances for the funds to be paid directly to the applicant if the landlord refuses to accept direct payment.

Ronald E. Finley, County Legislator, asked about foreclosure assistance. Mr. MacDonald said most funds are allocated for rental assistance, but they have also provided legal assistance in restructuring loans and other issues with foreclosure situations. Mr. Finley asked about aid for people who have a judgment executed. Mr. MacDonald said Legal Aid has been working to identify tenants through courthouse outreach. They have also provided aid in satisfying judgments because the judgment can be a deterrent to being able to find new housing. Judge Dale Youngs, Presiding Judge, said the current CDC moratorium on evictions runs to the end of June 2021.

Dan Tarwater III, County Legislator, asked Troy Schulte, County Administrator, to address resolution 20648. Mr. Schulte said this will put funds in place to handle the emergency repairs to the County Courthouse chilling system to provide air conditioning in the building. Brian Gaddie, Director of Public Works, said the County is undergoing a facilities assessment that will examine all of the County's systems. While this measure will provide a temporary fix to the problem, they expect it will repair the system for about five years. The County's heating and cooling systems are complex and inter-connected. This will buy time in the process of evaluating the whole climate control system.

Dan Tarwater III asked about the emergency declaration related to the Fred Arbanas Golf Course. The golf course is closing for a month to re-sod the greens due to a mistaken application of chemicals last fall. Frank White, Jr. said they have completed the first nine holes. The sod is coming from Colorado so it may be dormant for a few more days.
