3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

4 HEARINGS

Public hearing on the extension of the Jackson County mask mandate.

Presentation by Bridgette Shaffer, Director of the Jackson County Health Department, Ray Dlugolecki, Assistant Director of the Jackson County Health Department and Dr. Mark Steele, Executive Chief Clinical Officer for Truman Medical Centers. Dr. Mark Steele thanked the County Legislature and County Executive for the \$27 million in support for their COVID preparation which has been critical with the Delta variant surge that they are now experiencing. He said the Emergency ICU and additional beds at TMC Lakewood were totally full at the end of last week. In addition to purchasing additional equipment, TMC was able to create negative pressure isolation rooms to help keep staff safe while caring for the significant surge in COVID patients. There are 61 COVID patients admitted between the two TMC campuses. Patients requiring hospitalization are those not fully vaccinated. There are 20 patients in ICU, 4 are on ventilators. They are currently holding 13 admitted patients under Health Sciences District ED due to no open beds. On Friday and Saturday there were no ICU beds but over the weekend there were 4 COVID deaths which freed up some beds. Patients are very sick. Currently there is data out of Great Britain suggesting that people are twice more likely to be hospitalized when infected with the delta variant than the original strain. This is predominately true in unvaccinated individuals. There have been 22 COVID related deaths in August; 2 patients were in their 30's, 4 patients were in their 40's. This is a serious outbreak that is putting a lot of pressure on local hospitals. As of today, 5 hospitals in the metro area are on high volume and staffing the available beds is a challenge as well.

Bridgette Shaffer said the Jackson County Health Department strongly supports the extension of an Order requiring masks, regardless of vaccination status in all indoor places within Jackson County, Missouri.
