Charlie Franklin, Chairman, called the meeting of the Jackson County Legislature to order.

2 THE PLEDGE OF ALLEGIANCE

3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Dan Tarwater III, seconded by Scott Burnett to approve the journal of the previous meeting held on January 18, 2022. The motion passed by a voice vote.

4 HEARINGS

JCDC Partners, LLC gave an update regarding the Jackson County Detention Center project. Brian Gaddie, Director of Public Works, introduced the JCDC Partners team: Dr. Troy Nash, Rick Davidson, Dan Musser, Dan Wehmueller, and Babette Macy. Dr. Nash said they have made exciting progress on the project. A Pre-Proposal Meeting was held on January 4, 2022, at the Truman Sports Complex. More than 100 people attended including many members of the trades and several minority- and women-owned business representatives. Members of the engineering, contracting, and architectural community also attended. County staff and JCDC Partners gave a detailed presentation regarding project engagement opportunities. The Request for Qualifications for the design-build team was received on

January 18, 2022. The County Evaluation Committee made a short list of qualified teams to proceed to the second step in the solicitation process. JCDC, in collaboration with County staff, have completed the request for proposals. Staff plans to issue the RFP to the short list of candidates today. Reponses are due February 21, 2022, with interviews to be scheduled the following week. The selected team will be brought before the Legislature for a vote shortly thereafter. They plan to have the design-build team on board by spring. Pursuant to Resolution #20802, adopted November 8, 2021, the Legislature will continue to approve the project in phase component packages. This will include three additional project phases in addition to preconstruction. They anticipate component package one will include site and foundation scope, component package two will include the building core and shell, and component package three will include the interior fit out. At each interval the Legislature will be presented with the maximum price for the entirety of the project in each component package.

JCDC Partners will continue to manage the budget and schedule. They will ensure the integrity purpose and goals of the project as developed by the Steering Committee.

Ronald E. Finley, County Legislator, asked about the calendar and when construction will begin. Brian Gaddie said he would forward the detailed matrix of dates to Mr. Finley. Mr. Gaddie said March 7, 2022, will be the notice of award. They will develop a notice to proceed date and that will clarify when construction begins. Mr. Finley asked how these dates will impact the relocation of mobile home park residents. Mr. Gaddie said they hope to have all residents relocated by February 28, 2022.

Dan Tarwater III asked about the respondents to the RFQ. Mr. Gaddie said they were comfortable with the respondents they received. To qualify for the RFP, you have to qualify for the RFQ. Mr. Tarwater asked if the respondents will make presentations before the Legislature. Mr. Gaddie said the process is a closed file. The Evaluation Committee will make a recommendation to the Legislature. Troy Schulte, County Administrator, said they are down to fewer than 30 residents of the mobile home park to be relocated.
