WHEREAS, by Ordinance #5822, dated December 18, 2023, the Legislature did authorize a submission to the qualified voters of Jackson County, a ballot question on the April 2, 2024, ballot

regarding a sales tax for the purpose of retaining the Kansas City Royals and Kansas City Chiefs sports teams in Jackson County, Missouri; and,

WHEREAS, the cost of this special election totals \$1,006,228.00 and is divided between the Kansas City Election Board and the Jackson County Election Board, based on population, and offset by currently scheduled ballot measures from other jurisdictions; and,

WHEREAS, the County will seek to reimburse itself for this expenditure from proceeds of the tax question submitted at the election, if adopted by the voters; and,

WHEREAS, a transfer is necessary to cover the election costs; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer within the 2024 General Fund be and hereby is made:
