**ORDINANCE # 3651,** July 25, 2005

WHEREAS, the Jackson County Health Department has been awarded a grant in the amount of \$270,757.00 by the United States Department of Health and Human Services to provide treatment services to a client population as a jail diversionary measure; and,

WHEREAS, this is the third year of this grant program; and,

WHEREAS, this grant is subject to an in-kind match in the amount of \$98,167.00, to be provided by subcontracted service providers; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; and,

WHEREAS, the grant term is June 1, 2005 through May 31, 2006; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the unappropriated surplus of the 2005 Grant Fund be and hereby is made:
