WHEREAS, the owners has agreed to convey said permanent drainage easement, and to settle the claim for damages and have executed this conveyance in favor of the County in consideration of the total payment of \$30.00; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Manager of the Division of Finance issue a check in the amount of \$30.00 in the name of Robert and Nina Reese, and that the check be delivered to the Department of Public Works, c/o Kaye Merkle, Engineering Division, for appropriate disposition.
