ORDINANCE # 3228, February 25, 2002

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the United States Department of Justice has awarded the Heart of America United Way a grant in the amount of \$500,000.00 for its Kidsafe program; and,

WHEREAS, of this sum Heart of America United Way has awarded a subgrant in the amount of

\$69,722.00 to the Prosecuting Attorney's Office to cover 75% of the salary of an assistant prosecuting attorney and other related costs, to support the Kidsafe program; and,

WHEREAS, said subgrant is subject to a \$19,534.00 local match; and,

WHEREAS, a transfer and appropriation are necessary to place the subgrant and matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; and,

WHEREAS, the attached Agreement sets out the understanding of the parties regarding this grant program; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby are made:
