AN ORDINANCE amending the districts established by the Jackson County Zoning Order by changing from District A (Agricultural) to District LI (Light Industrial) a certain 4.4± acre tract.

ORDINANCE # 3452, December 1, 2003

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "A" (Agricultural) District and the "LI" (Light

Industrial) District so that there will be transferred from District A to District LI a tract of land
described as follows:
Description: The $4.4\pm$ acre lot approximately $1/4$ of a mile east of Curtis Road on the north side of Meyers Road and legally described as Lot 1 of Reiger Potato Co., a subdivision in Jackson County, Missouri aka 22500 Meyers Road.
Section 2. The Legislature, pursuant to the application of Reiger Potato Company, Inc., (RZ-2003-
327), requesting the amendment embodied in this ordinance and with notice that the Jackson County
Plan Commission unanimously recommended this application in a public hearing on November 20,
2003, does adopt this ordinance pursuant to the Jackson County Charter authorizing the Legislature
to exercise legislative power pertaining to planning and zoning.
