ORDINANCE 2859, October 13, 1998

INTRODUCED BY Dennis Waits, County Legislator

WHEREAS, the United States Department of Justice has awarded the Heart of America United Way a grant in the amount of \$50,056.00 to cover 75% of the salary of an Assistant Prosecuting Attorney for its Kidsafe program; and,

WHEREAS, said grant is subject to a \$15,236.00 local match for which a transfer and appropriation are necessary; and,

WHEREAS, the attached Agreement is a suitable mechanism by which funds for the grant can be implemented; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the unappropriated surplus of the 1998 Grant Fund:
