WHEREAS, pursuant to Invitation to Bid No. 36-10, the Director of Finance and Purchasing has solicited formal written bids for the furnishing of inmate commissary services for use by the Department of Corrections; and,

WHEREAS, in the requested solicitation prospectus, suppliers were advised that the contract would be awarded based on the lowest prices proposed to be charged to the inmate customers, with a twenty percent (20%) commission to be payable to the County; and,

WHEREAS, a total of ten (10) solicitations were distributed and four (4) responses were received as follows:
