AN ORDINANCE appropriating \$42,250.00 from the fund balance of the 2009 Anti-Drug Sales Tax Fund and authorizing the County Executive to execute addenda to the Cooperative Agreements with Boys & Girls Club of Greater Kansas City, ReDiscover, Inc., and Rose Brooks Center, Inc., at an aggregate cost to the County not to exceed \$42,250.00.

ORDINANCE #4103, May 11, 2009

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, by Ordinance 4085, dated February 2, 2009, the County Legislature did authorize the execution of agreements with certain outside agencies for anti-drug prevention activities and purposes, which included Boys & Girls Club of Greater Kansas City, ReDiscover, Inc., and Rose Brooks Center, Inc; and,

WHEREAS, a calculation error occurred in determining the 2009 funding level for these organizations; and,

WHEREAS, COMBAT staff recommends the approval of addenda to the cooperative agreements with these agencies to ensure that all prevention agencies received equal reductions to their 2008 funding levels; and,

WHEREAS, an appropriation is necessary to cover these costs; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the fund balance of 2009 Anti-Drug Sales Tax Fund be and hereby is made:

BE IT FURTHER ORDAINED that the County Executive be and hereby is authorized to execute addenda to the Cooperative Agreements with Boys & Girls Club of Greater Kansas City, at a cost to the County not to exceed \$12,500.00, ReDiscover, Inc., at a cost to the County not to exceed

\$21,250.00, and Rose Brooks Center, Inc., at a cost to the County not to exceed \$8,500.00, in a form to be approved by the County Counselor; and,

BE IT FURTHER ORDAINED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the agreements and addenda thereto.
