ORDINANCE NO. 5470, December 7, 2020

WHEREAS, U.S. President Donald J. Trump, Missouri Governor Mike Parson, and County Executive

Frank White, Jr., have all declared, in one form or another, the ongoing Coronavirus/COVID-19 pandemic to be a public health emergency; and,

WHEREAS, the County, through its various efforts, plays a significant role in the public health of its citizens and employees; and,

WHEREAS, an appropriate response by the County to this emergency will require significant expenditures from the County CARES Act Fund, which consists of monies provided by the U.S. Treasury for this purpose; and,

WHEREAS, the funding provided by this appropriation will be used to reimburse the Parks + Rec Department for public safety costs in dealing with the pandemic such as salaries and overtime costs for park rangers; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
