ORDINANCE # 3797, August 14, 2006

WHEREAS, the Kansas City Metropolitan Crime Commission (KCMCC) has awarded a grant to the Prosecuting Attorney's Office in the amount of \$45,000.00, for its Project Safe Neighborhoods

program, which the County will use to fund one full-time prosecutor to assist in the prosecution of federal and/or state criminal charges related to firearms crimes; and,

WHEREAS, this grant is subject to a local match in the amount of \$48,769.00; and,

WHEREAS, a transfer and appropriation are necessary to place the matching and grant funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,
