K.C. Community Center and Swope Health Services; and,

WHEREAS, the bid from Dismas House is non responsive due to the fact that Dismas House is not certified to provide alcohol and drug abuse treatment by the Division of Alcohol and Drug Abuse as required in RFP No. 65-04; and,

WHEREAS, he has received as the only three qualifying bids from the following:
