WHEREAS, section 137.115 of the Revised Statutes of Missouri (2000), requires the County Assessor, or his equivalent in Jackson County, the Director of Assessment of the Division of Finance, to submit a two-year assessment and equalization maintenance plan to the County Legislature; and,

WHEREAS, section 137.115 further requires approval of that plan by the County Legislature within thirty days of its submission; and,

WHEREAS, the Director of Assessment has submitted a two-year plan in accordance with the requirements of section 137.115, and monies required for said plan have been appropriated by the County Legislature for deposit in the Assessment Fund; therefore,
