INTRODUCED BY Henry C. Rizzo and Dan Tarwater, County Legislators

WHEREAS, the County has an ongoing need for the public disposition of its property by sale or value; and,

WHEREAS, it is in the best interest of the County to expand venues by which sales of surplus property are conducted to include the use of online services; and,

WHEREAS, the Director of Purchasing recommends amending procedures related to the surplus of personal property owned by Jackson County by authorizing the sale of county property by way of online services; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, as follows:

Section A. Enacting Clause.

Sections 1136.1, <u>Jackson County Code</u>, 1984, is hereby repealed, and one new section enacted in lieu thereof, to be known as sections 1136.1, to read as follows:

1136.1 Where Conducted.

All auctions or garage sales shall be conducted on county property, unless the Director of Purchasing contracts with a qualified vendor <u>or online service</u> to conduct the auction or garage sale. In such cases, the auction or garage sale may be conducted <u>online or</u> at a site selected by the
