welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County

Counselor be, and hereby is, authorized to settle the claim of David L. and Kimberly A. Mullnix in the

case David L. Mullnix and Kimberly A. Mullnix v. Jackson County, Missouri, Case No. 0616-

CV32162, by the total payment of \$30,000.00, in full, final, and complete release of all of Mr. and

Mrs. Mullnix's claims against the County and all of its employees, officers, agents, and servants as to

damages incurred in November 2004; and,

BE IT FURTHER RESOLVED that the County Counselor be and hereby is authorized to execute any

and all documents necessary to effect this settlement; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to issue

checks in an amount totaling \$30,000.00 in full and complete settlement of this claim, pursuant to the

specific instructions of the County Counselor.
