AN ORDINANCE amending Schedules II and IV to Chapter 52, Jackson County Code, 1984, relating to the traffic code.

ORDINANCE 2596, October 21, 1996

INTRODUCED BY John C. Graham, County Legislator

WHEREAS, changing traffic patterns and updated traffic engineering studies indicate the need to amend the County's present traffic code to include the following schedule changes; therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri that Schedules II and IV to Chapter 52, Jackson County Code, be amended as follows:

Section A. Enacting Clause. Schedules II and IV to Chapter 52, Jackson County Code, 1984, are hereby amended as follows.
