WHEREAS, the Missouri Department of Transportation, Traffic and Highway Safety Division, has

awarded the Sheriff's Office a Hazardous Moving Violation Enforcement grant in the amount of

\$19,500.00, for the grant period of October 1, 2021, through September 30, 2022; and,

WHEREAS, through this grant funding, the Sheriff's Office is better able to effectively conduct

enforcement actions in order to decrease speed, hazardous driving related injuries, and fatality crashes; and,

WHEREAS, the Sheriff recommends the use of the grant funds for reimbursement of overtime used for conducting hazardous moving violations enforcement at various locations throughout the County and for travel and training of traffic unit personnel; and,

WHEREAS, an appropriation is necessary to place the grant funds in the appropriate spending accounts; now therefore,
