the health, welfare, and safety of the citizens of Jackson County; now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive
be and hereby is authorized to execute the attached Cooperation and Use Agreement with Kansas
City Pop Warner, Inc.
