ORDINANCE 2465, October 16, 1995

WHEREAS, the County and John McEnroe entered into an agreement dated February 27, 1995, for the position of Financial Drug Advisor, the County Legislature, and now desire to enter into an addendum to said agreement, a copy of which is attached hereto; and,

WHEREAS, the Financial Drug Advisor shall continue to be paid the sum of \$60.00 per hour, in an additional amount not to exceed \$5,000.00, for a new total not to exceed \$35,000.00, during the term of said agreement; therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the 1995 Anti-Drug Sales Tax Fund:
