WHEREAS, the proposed Change Order No. 1 (Final), a copy of which is attached hereto and incorporated herein by reference, is necessary to adjust the contract plan quantities to as-built quantities, and to construct abutments and set a new bike/pedestrian bridge in the Little Blue Trace Park, and said change order will result in an increase not to exceed \$2,821.91; therefore,
